Note 22: laundry has been more expensive because of the soap and repairs.

Note 27: interests: we did good last year but we are being conservative in the new budget. We don't want to overestimate it unnecessary

We are missing 900000 kr. which will be solved by a rent increase by 3,18%. 80 kr. for single rooms and 125 kr.
